RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

In consideration of _____ participating in the program at Chenango Gymnastics, I represent that I understand the nature of this activity and that my child is qualified, in good health, and in proper physical condition to participate in such activities. I understand that it is the expressed intent of Chenango Gymnastics to provide for the safety and protection of my child. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the activity. I fully understand that this activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by their own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releasees" named below, and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages incurred as a result of participation in the activity.
